**SPECIAL INSTRUCTIONS**

Connecticut law allows you to receive an absentee ballot if you cannot appear at your assigned polling place on election day because of active service in the Military, absence from the town during all of the hours of voting, illness, religious tenets forbid secular activity on the day of the election, duties as an election official at a polling place other than your own during all of the hours of voting, or physical disability. The State of Connecticut, via Senate Bill 1202 of the June Special Session 2021, has determined that the existence of the COVID-19 virus allows you to vote by absentee ballot if you so choose for your own safety.
